


WHAT WE DO

2018 – 2019 was a milestone year for the Haywood County Schools Foundation. Students, schools and employees of Haywood County Consolidated Schools have so many new opportunities because of the commitment our community continues to make. The wide range of caring individuals and organizations throughout our county are remarkable and deserve our sincerest thanks.

HCSF assets increased to over \$5 million this year, allowing more funding for scholarships, classroom grants, student activity grants, district-wide professional development, and assistance for many of the needs of our students and employees.

The fundraising efforts for the HCS Foundation again exceeded projected goals. With only two major fundraisers, BINGO and Mardi Gras, public support is reassuring. Continuing to pursue excellence in education

Among the 115 school districts in North Carolina, Haywood County Consolidated Schools ranked 11th based upon the district performance composite for the 2017-18 school year; ranking us in the top 10 percent in the state. This is up from a district ranking of 15th during the 2013-14 and 2014-15 school years.

Since 2013, the state has issued school letter grades to each public school and Haywood County Consolidated Schools has remained in the elite group of school districts with no “D” or “F” schools. The following chart presents the percentage of schools by letter grade for all North Carolina schools, charter schools and Haywood County Consolidated Schools.




The Haywood County Schools Foundation awarded more than \$159,000 in grant money to teachers, schools, and student activities.

Grants were sponsored by Evergreen Packaging, First Citizens Banks, QuickDraw, the Arc of Haywood County, and the Haywood County Schools Foundation. Grants fund resources for teachers and staff to enrich the learning experience for students. Grants ranged from \$200 to purchase LEGO kits for a fairy tale literature unit in a kindergarten class at Clyde Elementary, to \$350 to purchase power grid models for Waynesville Middle School's STEM class, to \$375 to buy interview-appropriate attire for Pisgah High School Exceptional Children (EC) students.

Each teacher grant sponsor has different requirements and focuses of study. The Evergreen Packaging grant provides funds for STEM (science, technology, engineering, and mathematics) projects and programs. The First Citizens Bank grant provides funding to schools and teachers for reading initiatives. Professional growth and development is the focus of the Haywood County Schools Foundation grant. The QuickDraw art grant provides funds for art teachers to purchase materials.



ROBOTHON INSPIRES CODING & CREATIVITY



Students worked to apply classroom instruction to hands-on, competitive situations during Haywood County Schools' Middle School Wolfpack Robothon competition last week.

The Wolfpack Robothon, held at the Hazelwood Conference Center, was a collaboration between Haywood County Schools' Academically and Intellectually Gifted (AIG) program, Haywood Early College, and Haywood County Schools' Instructional Technology Center (ITC).

More than 150 sixth and seventh graders from the district's three middle schools participated in robotic challenges that included a skatepark, soccer, and archery.

"Experiences like Robothon are preparing our students for the future," Belinda Marr, Haywood County Schools AIG director,

said. "We want our students to graduate with a usable understanding of technology, so that they can use it and create it."

Coding is essentially writing instructions for a computer to perform. Proficiency in coding allows students to understand the technology shaping the world.

Marr said students are learning coding beginning in elementary school, so they can build their knowledge and skills each year.

"As technology continues to expand, both in scope of possibility and sphere of influence, students need to understand how to utilize it for good," William Yates, Waynesville Middle School AIG teacher, explained. "Knowing how to code is merely the first step. The second step is much tougher - that of why we code, and what we are coding for."

Coding was just one aspect of the event. Along the way, students had to problem-solve, design, and test before they could execute a code. Even then, a code might not work. Students then had to have the patience to start from the beginning to correct the code until the robot worked correctly.

"I like the challenge a lot because it keeps you busy and entertained," Molly McConnell, a sixth grader at Waynesville Middle School, said. "I like coding because it's a challenge, and you have to figure out what goes where."

This is the school district's second Robothon competition. The first event was held last November for elementary-aged students.

In May 2019 at the Foundation's Partners in Education awards ceremony, 103 high school seniors from Pisgah, Tuscola, Central Haywood, and Haywood Early College received 148 scholarships totaling \$253,500. Scholarships ranged from \$250 to \$40,000.

Pisgah senior Eric Meyer was shocked to find out he had received six scholarships totaling \$4,750.

"I didn't expect this, and I'll forever be grateful to the committees for choosing me because this is going to allow me to pursue my dreams," Meyer said. "I want to make a huge impact in the music world for generations to come."

Currently, the Foundation manages more than 75 scholarships that have been established by businesses and individuals in the community. Scholarships may be endowed or funded annually.

MARDI GRAS BALL

The Mardi Gras Ball, sponsored by Entegra Bank, raised more than \$88,000 in February 2019. Congratulations to this year's King Adam Bridges and Queen Celeste Ybanez. Since the first Mardi Gras Ball in 2008, the event has raised nearly \$700,000 for scholarships, classroom grants, and support services for Haywood County Consolidated Schools. Each year, dedicated community members volunteer to run as candidates for the Mardi Gras court. The 2020 Mardi Gras Ball is planned for Saturday, February 29 at Laurel Ridge Country Club.

To date, Richie's Alliance for Autism has donated \$83,000 to the Haywood County Schools Foundation.



On April 29, Richie's Alliance for Autism donated \$54,000 to the Haywood County School's Foundation to support the district's Exceptional Children's department and to create scholarships for graduating seniors. Richie's Alliance celebrated April as National Autism Awareness month with three days of fundraising and awareness-raising events.

This year's events included a Casino Royale Autism Awareness Golf Tournament presented by Ken Wilson Ford at Laurel Ridge Country Club; Richie's Alliance Dine Out/Shop Out Day, supported by numerous Haywood County businesses; and Richie's Alliance for Autism 'Taste,' presented by Harrah's Cherokee Casino Resort at Laurel Ridge Country Club & Event Center.

“This money will be used for resources for students with disabilities and for student scholarships,” Brandi Stephenson, HCS Exceptional Children program director, said. “We are completely overwhelmed by the kindness and generosity of our community

through the Richie’s Alliance events.”

Louis and Debbie Perrone, owners of Frankie’s Italian Trattoria in Maggie Valley, began raising money for local autism services in 2015. Frankie’s and a few other restaurants raised about \$5,000 for the Olson Huff Center at Mission Children’s Hospital with a Dine out for Autism event.

The next year, the couple established Richie’s Alliance in honor of their son, Richie, who has autism.

“After that first year, I knew that this could be something really big,” Louis explained. “We created Richie’s Alliance the next year in hopes to grow the event and raise more money for autism services.”

The Perrones succeeded and have raised nearly \$250,000 over the past four years for local autism services. This year, all money raised was donated to the Haywood County Schools Foundation to support the district’s Exceptional Children’s program.

The Exceptional Children’s program provides specially designed instruction to ensure that all children with disabilities, ages three through 21, have free, appropriate public education. The program emphasizes special education and related services designed to meet their unique needs and prepare them for further education, employment, and independent living. Services include specialized educational instruction, speech/language therapy, occupational therapy, physical therapy, hearing impaired services, visually impaired services, and transportation.

“Richie will be in eighth grade at Waynesville Middle School, and he has assistance in the classroom,” Debbie explained. “Richie could not have been as successful in school without his aide, and we wanted to ensure that any child who needs help gets it.”

The scholarships from Richie’s Alliance are open to any Haywood County Schools senior who has special needs.

“I want the scholarships to be for those students who otherwise feel like college might be out of their reach,” Debbie explained. “I hope that these scholarships will be an incentive for them and encourage them to follow their dreams.”
